REPORTS AND RECOMMENDATIONS FOR ACTION

#23-01 Approval of amended FY2023 Capital Budget

- a. Victor Celentino moved the Capital Region Airport Authority Board approve the amended FY2023 Capital Budget involving decreases to mill levy funded and CARES funded capital expenditures and an increase to Customer Facility Charge (CFC) funded capital expenditures.
- b. The motion passed unanimously.

Sunil Khetarpal – Financial Report for period ending 11/30/2022

YTD Operating Revenue

Current month is \$39K over budget; overall YTD is \$46K over budget.

- Airline revenues are lower by (\$47K) all around weakness.
- Concessions (rental cars) revenues are above budget by \$46K.
- Parking, Fuel & Remaining revenues are above budget by \$48K.

YTD Operating Expense

Current month is under budget by \$41K, overall YTD \$158K under budget.

- Employee Development Education & Training under budget by \$8K.
- Maintenance expenses were over budget by (\$37K) due to summer airfield maintenance and HVAC, will balance out during the year.
- Services are under budget by \$11K.
- Payroll is below budget by \$43K on lower wages and health insurance costs.
- Utilities and Fuel are under budget by \$41K
- Business Development is under budget by \$72K

Mason Jewett Field

- Revenues were higher than budget by \$12K due to fuel sales.
- Expenses were lower than the budget by \$1K.

Debbie Groh inquired about the vacant position in Mason; Nicole reported that the position has been filled; Chris Speckin will be introduced at the February 1 tenant meeting.

Grant Balances will be requested/received prior to due dates. John Shaski commented on the great work of staff in applying for and using the grant money in the allotted time frame.

Quarterly Tenant Meetings at Mason Jewett Field have been scheduled for Feb 1, May 3, August 2, and November 1 from 5:30 – 6:30 pm.

Apple Vacations flights will kick off on Saturday, January 28. There will be three flights per week to Cancun, 2 flights per week to Punta Cana, and one flight to Jamaica.

We will be supporting the American Airlines' FAA slot exemption for DCA. Voter's Voice will be utilized to provide easy support letter submittal.

Delta Airlines will be switching to CRJ900 aircraft (76 seats) in mid-March. John Shaski mentioned that CRJ900s usually are parked at terminal A in Detroit which could mean easier connections.

Avelo Airlines switched to AM departures on January 12, 2023. John Shaski shared that he had experienced a couple delays with Avelo's evening departure, but the Brewport stayed open late, and the staff were super busy.

We continue to engage with the community; Nicole presented at the Mount Pleasant Rotary today and Katherine Japinga is scheduled to present to a Convention & Visitors Bureau group tomorrow.
