Niowave presentation on proposed expansion – Mike Zamiara & Dino Muzzin

Mike Zamiara shared details on Niowave's leadership team and company history.

2006: Niowave headquarters established in Lansing

2010-2012: DOE Nuclear Physics Phase II SBIR Project Funding

2012: Facility Expansion R&D Annex

2014: Production Facility

Why Niowave? Nuclear Engineering; Radiochemistry; Regulatory Mission: We manufacture radioisotopes to cure cancer and save lives.

ACC225 Treating Cancer

- Study was published in 2016 using Ac225-PSMA-617 to treat prostate cancer for two patients in challenging clinical situations.
- "The implantation of 225Ac-PSMA-617 for therapy of metastatic castration-resistant prostate cancer constitutes a major advancement in targeted alpha therapy" (Morgenstern et. Al, 2018).
- Patient A was treated with 4 doses of 240-270 uCi Ac-225 at biweekly intervals.
 PSA reduced from 2.923 ng/mL to <0.1 ng/mL
- Patient B was treated with 3 doses of 170 uCi Ac-225 after receiving two ineffective treatments of Lu-177.
 PSA reduced from 294 ng/mL to <0.1 ng/mL

Dino Muzzin shared details on the expansion of their radioisotope manufacturing facility.

Site Masterplan: expand footprint in multiple phases creating a corporate campus.

Phase 1 increases from 1.5 acres to a total of 6.73 acres for existing and new manufacturing facility. Phase 2 adds additional 4.42 acres for new headquarters.

Design: Q2-Q4 2025 Permits: Q3-Q4 2025

Construction: Q4 2025 - Q4 2026 C & Q: Q4 2026 - Q1 2027

Turnover: Q1 2027

Congratulations to Elliott Black for earning his Master of Public Administration degree.

The Authority is excited to support Niowave's expansion plans.

The BETA Electric Charger ribbon cutting will be held July 30 at Avflight Lansing, the Fixed Base Operator at the airport. LAN is proud to be the first in Michigan to bring an aircraft charger online. This milestone was made possible thanks to the incredible support of MEDC, MDOT, LBWL, City of Lansing, and the dedicated LAN Team.

CRAA is hosting an AIAM (Aerospace Industry Association of Michigan) luncheon on July 30; attendees were invited to the BETA Electric Charger ribbon cutting event as well.

The next quarterly Mason Jewett Field Tenant meeting will be held July 30. The agenda includes Active Shooter Training at Mason High School, Terminal Cameras update, AWOS relocation with MDOT, Terminal Ramp Rehabilitation Project update, Wildlife Hazard Management update, and USDA quarterly report (April-June).

CRAA has met with our airline partners (Delta, American, Breeze, and Apple Vacations) to discuss winter operations and ground handling activities. Meetings included representatives from their headquarter and local levels to maintain an ongoing focus.

The \$7.83 million funding for jet bridges has passed the Federal House Appropriations and now goes to the Senate.

Yvette Collins asked about the maximum miles the BETA aircraft can travel; staff indicated 350-386 miles.
