PROJECT DESCRIPTION: **TAXIWAY TURNING IMPROVEMENTS – PHASE 1**
BID DUE DATE: **May 6, 2016**

Sealed bids will be received by the **Capital Region Airport Authority**, at the Administration Office until 1:00 p.m. (local time), on the bid date, at which time and place all bids will be publicly opened and read aloud. **ANY BID RECEIVED AFTER THE SPECIFIED TIME WILL NOT BE CONSIDERED.**

The proposed Work includes the following: **Approximately 7,200 tons of new bituminous asphalt airfield pavement and paved shoulders, 6,900 square yards of new concrete airfield pavement, rehabilitation of existing asphalt and concrete airfield pavement, taxiway edge lighting and guidance signage improvements, pavement markings, and restoration.**

Bidder Qualifications

Prime Bidder must be prequalified with MDOT. The net classification required for this project is 3000 Cb (Hot Mix Asphalt/Bituminous Paving) or 3000 B (Concrete Pavement). If the prime bidder is not prequalified in both classifications (Cb and B), then it must use a prequalified contractor for the classification for which it is not prequalified.

In addition, this project includes Designated Item classifications of Ea (Grading, Drainage Structures and Aggregate Construction) and L (Electrical Construction). If the prime bidder is not prequalified in these Designated Item classifications, then it must use a subcontractor that is prequalified in classifications Ea and L. These subcontractors must be designated prior to award of the contract to the confirmed low bidder.

There is a Disadvantage Business Enterprise (DBE) participation goal of 5.72% for this project.
